Notification

In pursuance of Section 17(1) of the Commissions for Protection of Child Rights Act, 2005 No. 4 of 2006, the Governor of Himachal Pradesh is pleased to constitute Himachal Pradesh Commission for Protection of Child Rights with immediate effect with its headquarter at Shimla.

The Commission shall consist of the following Members:-

- (a) A chairperson who is a person of eminence and has done outstanding work for promoting the Welfare of Children; and
- (b) A Member Secretary who is an officer not below the rank of the Secretary to the State Government; and
- (c) Six members, out of which at least two shall be women, from the following fields, to be appointed by the State Government from amongst persons of eminence, ability, integrity, standing and experience in,-
 - (i) Education;
 - (ii) child health, Care, welfare or child development;
 - (iii) juvenile justice or care of neglected or marginalized children or children with disabilities;
 - (iv) elimination of child labour or children in distress;

- (v) child psychology or sociology; and
- (vi) laws relating to children

Tenure of the office of the Chairperson and every Member shall be for a term of three years from the date on which he/she assumes office; provided that no Chairperson or a Member shall hold the office for more than two terms: provided further that no Chairperson or any other Member shall hold office as such after he has attained—

- (a) in the case of Chairperson, the age of sixty-five years; and
- (b) in the case of a Member, the age of sixty years.
